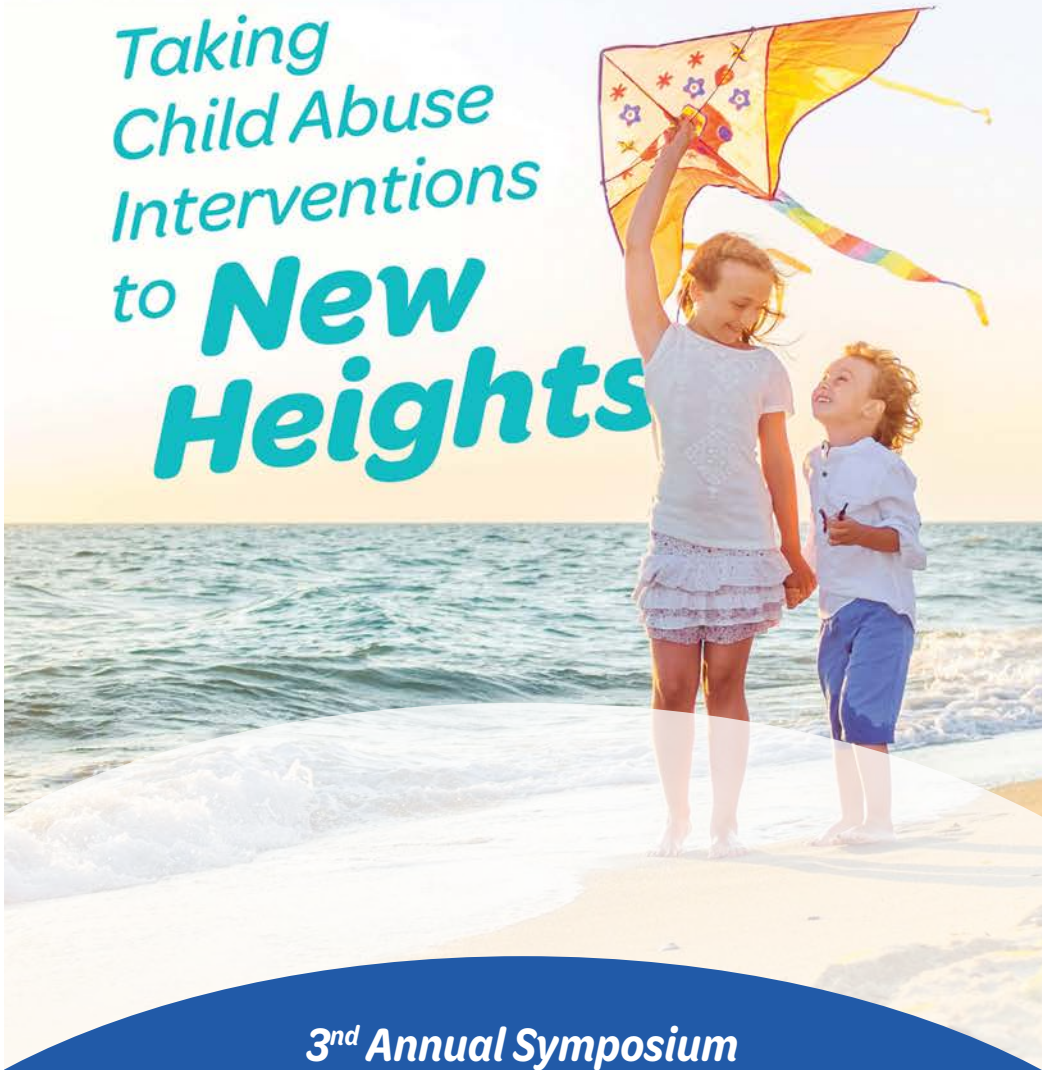

Target Audience

This symposium is appropriate for new and experienced law enforcement officers, DSS/CPS workers, prosecutors, medical professionals, mental health professionals (including psychologists & social workers), Guardians Ad Litem, case managers, juvenile justice workers, child advocacy professionals and victim service providers serving child victims.

Program Description

The 3rd Annual "Taking Child Abuse Interventions to New Heights" Symposium offers a multi-disciplinary training opportunity for professionals dealing with child abuse. Geared for professionals involved within a Multi-Disciplinary Team (MDT) as part of the children's advocacy center (CAC) model, this training allows for discipline-specific and/or cross-training of professionals in the investigation, evaluation, treatment and prosecution of child maltreatment cases.

Objectives

At the conclusion of this educational activity, the participant should be able to:

1. Recognize and describe the ways in which professionals dealing with child abuse (from their various disciplines) collaborate to make the investigation, evaluation and prosecution of child maltreatment cases stronger and more efficient.
2. Apply knowledge and skills to improve the multi-disciplinary response of professionals dealing with child abuse in the investigation, evaluation, treatment and prosecution of child maltreatment cases.

Continuing Education

Application for general Continuing Education Units (CEUs), Continuing Legal Education (CLEs) credits and Criminal Investigation Certificate Program (CICP) credits has been made to the Western Carolina University Continuing Education Department, the NC State Bar and the NC Justice Academy. Enrollment and/or payment for CEU credit is available online and all of these credits will be available in the registration area. If a fee applies to these credits, the responsibility for payment will be with the participant. The costs for any of the respective fees is not included in your registration fee.

Nursing Credit: This activity is being submitted to the Alabama Nurses Association for approval to award contact hours. Alabama State Nurses Association is accredited as an approver of continuing nursing education by the American Nurses Credentialing Center's Commission on Accreditation. Nurses must attend 100% of each session in order to receive credit for that session.



General Information

Registration Fees

Registration form(s) and payment are required from each participant to guarantee registration. Keynote Speaker: Kevin McNeil, M.Div

Kevin McNeil is a motivational speaker, abuse activist, and the CEO of the Twe12e Project, an organization that educates the world on the effects of abuse. Kevin retired from the DeKalb County Police Department after 20 years serving as a Police Officer and Special Victims Unit Detective. His training and attention to detail helped him solve several high-profile serial rape cases in Atlanta, Georgia. Kevin's background coupled with his extensive research on trauma and the effects of abuse both defines and differentiates his message. Kevin obtained his Master of Divinity Degree from the Interdenominational Theological Center in Atlanta, Georgia. He is the author of six published books focusing on empowering others to live out their God-given purpose.



Plenary Speaker: Chris Newlin, MS, LPC

Chris Newlin is the Executive Director of the National Children's Advocacy Center located in Huntsville, AL. He is responsible for providing leadership/management of the NCAC and participating in the national/international training and leadership activities for the protection of children. The NCAC was the first CAC in the world and continues to provide prevention and intervention services for child abuse in Huntsville/Madison County, AL. NCAC also houses the National Training Center, the Southern Regional Children's Advocacy Center and the Child Abuse Library Online (CALIO). Chris serves on numerous national/international Boards of Directors and Advisory Committees related to child protection and well-being. He was recognized as the 2010 recipient of the Hendrix College Odyssey Medal for service to the World and the 2010 recipient of the International Impact Award from the International Services Council of Alabama. Chris is a graduate of Hendrix College, the University of Central Arkansas and the Harvard Business School Executive Education Program.



Cory Jewell Jensen, MS, CCSOT

Currently the senior trainer for CBI Consulting, Cory has spent the last 35 years providing evaluation and treatment services to adult sex offenders and their families in Portland, Oregon. Cory has also provided training and consultation services to The National Center for the Prosecution of Child Abuse, The National Child Advocacy Center, The National Children's Alliance, The United States Navy, The National Crime Victims Association, The National Boy Scouts Foundation, The Mark McGwire Foundation for Children, US Marshall's Office, NYPD Special Victims Unit and a number of law enforcement, child advocacy and faith based organizations. She has published a number of articles related to sex offender treatment, risk management and child abuse prevention, testified as an expert witness in local and federal courts and been a featured guest on the Oprah Winfrey Show.



Françoise Mathieu, MS ED., CCC, RP

Françoise is the co-executive director of TEND, whose aim is to offer consulting/training to professionals on topics related to secondary trauma, compassion fatigue, burnout, self-care, wellness and organizational health. Françoise is a Registered Psychotherapist and a subject matter expert on topics related to compassion fatigue and secondary trauma. Her experience stems from over 20+ years as a mental health professional, working as a crisis counselor and trauma specialist in university counseling, military, law enforcement and other community mental health environments. Since 2001, Françoise has given hundreds of seminars on compassion fatigue and secondary trauma across North America and include presentations to members of St. Jude's Children's Hospital in Memphis, the LAPD, Mount Sinai Hospital and the Chief Coroner's Office of Ontario. She is one of the founding members of the Secondary Traumatic Stress Consortium and the author of "The Compassion Fatigue Workbook".



Amy Russell, MS ED., JD, NCC

Amy Russell is executive director of the Arthur D. Curtis Children's Justice Center in Clark County, Washington. She has worked with victims of violence and trauma including interviewer for suspected child victims of abuse and witnesses to federal and state crimes, counselor for survivors of homicide victims and pro bono attorney for abused children. She has also directed several CACs, provided training on child abuse investigations and authored multiple articles on forensic interviewing, child maltreatment and vicarious trauma.
